- 3. W-2 or Tax return with your name and address here in Denmark
- 4. Unexpired Passport or Passport Card

AND

1 of the following:

- 1. Copy of your Property Deed
- 2. Copy of a Signed Lease Agreement
- 3. **Notarized Letter** from the property owner or lessee if residing with a resident

Complete this as best as you can. We will help if necessary.

This form needs to be signed by the Parent or Guardian, and one of the Clerks must sign beneath you and Seal it with the Town Seal to verify all of the forms and information are up to date and accurate.

The Town will make a copy of all supporting documents and the application for our file in case the School District has any question about what was provided.
